#### DEAR FRIENDS—

**Proud.** It's the word we both think of when we reflect on the work United Way of Blount County accomplished in 2021. Following one of the most challenging years, we didn't know what 2021 would hold for our community. No words can overstate the impact of the continuing COVID-19 pandemic. It has altered our way of life, tested our resolve, and had tragic consequences for many. But in this adversity, we all showed up — our donors, our volunteers, our community partners and our staff — to combine our strengths to help those most in need.

We are proud of one of the most successful fundraising campaigns in our history. Together our community, under the leadership of Campaign Chair Kevin Painter, raised \$2,123,421 for the most vulnerable in Blount County. Almost 70 individuals and households stepped up and joined our Pillars Society, giving \$1,000 or more to United Way of Blount County. Additionally, our Major Firms division companies made history in 2021 by collectively raising over \$1 million! The campaign was full of energy and excitement, and we were even able to safely hold a few inperson meetings for the first time in a very long time.

**We are proud** that we broadened our revenue stream and received a \$45,000 grant from Arconic Foundation to expand our ALICE educational work, which includes Bridges out of Poverty and Poverty Simulations. We are grateful to train our community on the impact of socioeconomic class, how to better serve individuals in poverty, and how to build empathy and understanding along the way.

We are proud that we continue to award COVID-19 Response Fund grants. Blount County gave generously to this fund initially in 2020, and we received additional contributions from DENSO, City of Maryville and TVA to continue helping those affected by the pandemic in 2021.

We are proud of the priority we placed on building the knowledge, skill and competency to advance equity in our nonprofit work. United Way of Blount

County provided education to help nonprofit workers, volunteers and board members integrate a diversity, equity and inclusion framework into their efforts to create more equitable organizations. We will continue to work toward ensuring that everyone has access to a healthy, well-educated and self-sufficient life.

We are proud of the way we work in partnership through the toughest challenges with a solution-oriented mindset for movement and momentum. We hope you will take a few minutes to browse this report to see the impact United Way of Blount County has had on this community -- with you by our side.

We will continue to build on our strengths, drive accountability, and support our most vulnerable population. Thank you, Blount County, for an extraordinary year. We look forward to what 2022 holds for everyone.

#### Homeless Task Force

2021 saw the expansion of several main goals surrounding the Homeless Task Force. A Place

To Stay, a new nonprofit focused on referral and general support for our

homeless population,
began with a United Way
of Blount County grant.
UWBC funds supported
various service day
events that helped our
homeless population get
vaccinated for the flu,
COVID-19 and Hepatitis,
as well as general support.



#### Poverty Awareness

The need for poverty awareness and education continues to grow rapidly.

Thanks to a grant from Arconic

Foundation, we are now able to reach the regular requests for Bridges out of Poverty trainings, Poverty Simulations and ALICE Awareness discussions.

In 2021, we certified two additional Bridges trainers, provided 6 Bridges



workshops, and led Poverty Simulations for Maryville High School staff and Leadership Blount. We already have a nearly full calendar for these events in 2022.

### ADVOCATE

#### Diversity, Equity & Inclusion

Our office prioritized education and awareness for our nonprofit communities as it pertains to Diversity, Equity and Inclusion. Great work is happening in our community, but is it all equitable? We hosted a 4-part summer webinar series covering various DEI topics and concluded with a half-day seminar led by Evetty Satterfield from Advancing Lives LLC, and a Racial Wealth Gap simulation led by Bread for the World. All nonprofit staff, regardless of level and position, have a stake in advancing equity work in our community.

#### Impact

Beyond all the outreach work listed in this report, we continued to raise the necessary funds to support 43 nonprofit programs in the areas of health, education and self-sufficiency. More than 41,000 lives were positively changed through United Way of Blount Countyfunded services, and 81% of them are living as ALICE or in poverty.

Our largest areas of impact in 2021 were basic needs and prevention and treatment services.



43% reported they couldn't find a job that pays enough to survive.




30% of households below the ALICE threshold with children reported a household member had to work reduced hours or quit a job due to child care issues.




